The itinerary within the brochure has been devised by Dr. Peter Walker in collaboration with the Jerusalem Center for Biblical Studies. JCBS is a non-profit organization, offering Holy Land study tours, within a Christian-based Company, called Educational Opportunities. JCBS will be your hosts throughout your tour and are responsible for the delivery of the advertised itinerary. JCBS has appointed Dr. Walker to be your academic instructor for the duration of the study tour.

Peter Walker is working in a purely personal capacity in order to coordinate the registration process within the UK and will be responsible for the safe transfer of all necessary funds to JCBS. Peter will also be the Data Controller, handling your personal data in compliance with current UK/European GDPR regulations. The data completed on this Registration Form will be shared with JCBS/EOT, a trusted third-party, as this is necessary for the delivery of the programme and to facilitate the safe transfer of funds to the hosting organization. The data will be used to provide up-to-date information so that the best possible service is offered in a timely manner. The data will be stored by Peter Walker securely in password protected MSOffice files and stored on a private computer, and will not be stored on any website. **Land-costs**

The land-costs for this study tour are **£2120.00 GBP**

These prices are per person in shared accommodation. There is a Single Room Supplement of **£608.00 GBP**.

- Room allocations (for those willing to share in twin-bedded accommodation) will be made after consultation with Dr. Peter Walker by 06 February 2025.

**Deposit & Registration**

An initial deposit of £175.00 GBP is due now upon registration.

The final balance is due on 01 April 2025

**Included in the land-tour cost**

Modern air-conditioned private bus; 9 nights' accommodation with breakfast & dinner; guided sightseeing & entrance fees to all sites listed in itinerary; tips for driver & hotel; administration fees in UK; personal 'listening units' (or headphones) for groups of 15 or more.

**Not included in the land-tour cost**

Flight tickets, baggage fees and all airline costs; private airport transfers (at different time to main party); drinks at hotels and restaurants; optional sight-seeing during free time in the itinerary; all personal expenses (including e.g. passports, phone calls, laundry & other optional incidental extras); travel insurance (NB. This is a requirement prior to registration).

**Cancellation fees**

All passengers will be asked to confirm upon registration that they have taken out suitable travel insurance to cover this tour and its flights, including the following costs in the event of your cancelling your booking:

- from 60 days prior to departure to 31 days: £200 GBP
- less than 30 days prior to departure: 100%

**Fit to travel Statement**

Passengers registering for the tour accept the responsibility for being in good health and able to walk and travel on the tour. Because many of the sites are not accessible to the physically challenged and space limitations on tour buses, wheelchairs and scooters cannot be accommodated. Those needing oxygen or other ambulatory assistance will find the tour extremely limiting in their experiences. Persons using C-pap machines requiring distilled water will need to inform us ahead of time, so we can work with local operators to prepare as it is not always available. JCBS reserves the right to refuse or revoke travel to anyone who is, in the sole judgment of JCBS, incapable of group travel without causing undue demands upon the staff or other tour participants. Accessible rooms/cabins are limited and subject to confirmation after receiving the passenger's written request. **Changes to Itinerary**

Every effort has been made to ensure the accuracy of this brochure. While you will see all the sites listed in the brochure, the order of sites and/or days and number of days may be altered in order to accommodate unavoidable changes in airline or hotel schedules, as well as local conditions.

- If airline schedules require extra overnight accommodation, you will be charged at \$125.00 USD/double or \$175.00 USD/single; this expense should be covered in your insurance policy.
- If you yourself are planning to opt out of the main itinerary, you are to notify Dr. Walker in advance and in writing. If permission is granted, any transport or other costs that you incur will be your own responsibility.

**Price increases and currency fluctuation**
